## Minimum Balance Requirements for Regular Share Certificates and IRA Certificates

There is no penalty for minimum required distributions on IRA Certificates withdrawn at age 70½ or older. The annual percentage yield (APY) is based on the assumption that dividends will remain in the account until maturity. A withdrawal will reduce earnings.
